UBS AG, Australia Branch ("**UBS**") is jointly underwriting a \$273 million capital raising being undertaken by APN, comprised of an institutional placement and entitlement offer.

In connection with the institutional placement referred to above, UBS entered into a subscription agreement with APN with respect to 17,392,400 ordinary shares on 25 October 2016 ("**Subscription Agreement**"). Upon completion of the Subscription Agreement, UBS has obtained a relevant interest in approximately 8.29% of APN's ordinary securities.



## 1 Defined terms and interpretation

### 1.1 Definitions in the Dictionary

A term or expression starting with a capital letter:

- (a) which is defined in the Dictionary in Schedule 1 (**Dictionary**), has the meaning given to it in the Dictionary;
- (b) which is defined in the Corporations Act, but is not defined in the Dictionary, has the meaning given to it in the Corporations Act; and
- (c) which is defined in the GST Law, but is not defined in the Dictionary or the Corporations Act, has the meaning given to it in the GST Law.

### 1.2 Interpretation

The interpretation clause in Schedule 1 (**Dictionary**) sets out rules of interpretation for this agreement.

---

## 2 Conditions precedent

### 2.1 Conditions

The obligations of the Subscriber to subscribe for the Placement A Shares under clause 3.1 are conditional on:

- (a) (**Trading halt**) by 9.00am on the Institutional Opening Date, the ASX granting the Issuer a trading halt under Listing Rule 17.1 for a period of not less than 2 Business Days commencing on the Institutional Opening Date in connection with the Institutional Entitlement Offer and Placement;
- (b) (**Management Questionnaire**) responses to the Management Questionnaire having been given to the Joint Lead Managers to the Subscriber's reasonable satisfaction by 5.00pm on the day prior to the Institutional Opening Date;
- (c) (**Due diligence materials**) delivery of the Due Diligence Report contemplated by the Due Diligence Process Outline, together with all of the schedules, annexures and attachments to that report, and all other opinions, reports and sign offs as further contemplated by the Due Diligence Process Outline, which are to be addressed to the Joint Lead Managers or otherwise expressed to be available to the Joint Lead Managers, by 9.00am on the Institutional Opening Date, in a form and substance acceptable to the Subscriber (acting reasonably);

- (d) **(ASX Materials lodgement)** the Issuer releasing the ASX Materials to ASX by 9.00am on the Institutional Opening Date in a form and substance acceptable to the Subscriber (acting reasonably);
- (e) **(ASIC Relief)** by 9.00am on the Institutional Opening Date, ASIC having granted the ASIC Relief (and such relief not having been withdrawn or amended, other than in a manner acceptable to the Subscriber);
- (f) **(Debt Financing Agreement)** by 9.00am on the Institutional Opening Date, the Issuer and the financiers having validly executed the Debt Financing Agreement; and
- (g) **(Underwriting Agreement)** by 9.00am on the Institutional Opening Date, the Issuer and the Joint Lead Managers having validly executed the Underwriting Agreement.

## 2.2 Conditions not satisfied

If any of the conditions precedent in clause 2.1 are not satisfied or waived by their respective deadlines (or such later time as agreed with the Subscriber in writing), the Subscriber (in its absolute and unfettered discretion) may, by notice to the Issuer, terminate this agreement at any time before complying with its obligations under this agreement, such notice to identify any relevant condition precedent which is not satisfied or waived.

## 2.3 Benefit of the conditions

The conditions precedent in clause 2.1 are for the benefit of the Subscriber only and may only be waived by the Subscriber in writing in its absolute and unfettered discretion.

# 3 Subscription

## 3.1 Subscription

Subject to the terms and conditions of this agreement, the Issuer must allot and issue, and the Subscriber must subscribe for, the Placement A Shares:

- (a) for the Subscription Amount;
- (b) on the date of this agreement; and
- (c) free of any Encumbrances.

## 3.2 Time and place for Completion

- (a) Completion will take place at 10.30am on the date of this agreement at the offices of the Subscriber or any other time and place agreed between the parties.
- (b) The Timetable may only be amended by the Issuer with the prior written consent of the Subscriber.

## 3.3 Subscriber's obligations at Completion

At Completion, the Subscriber must give to the Issuer:

- (a) an application to subscribe for the Placement A Shares in the form set out in Schedule 2 (**Application to subscribe for Shares**); and
- (b) subject to the Issuer having first complied with clause 3.4(a), the Subscription Amount in Immediately Available Funds.

### **3.4 Issuer's obligations at Completion**

At Completion the Issuer must:

- (a) by 8.30am on the Completion Date, allot and issue the Placement A Shares to the Subscriber in consideration of the Subscription Amount; and
- (b) give to the Subscriber a certified copy of a resolution of its board of directors approving the Subscription.

### **3.5 Holding statement**

The Issuer must despatch a new holding statement in accordance with the Corporations Act and the Listing Rules in respect of the Placement A Shares issued pursuant to this agreement as soon as practicable after their issue.

### **3.6 Quotation**

The Issuer must apply for Official Quotation of the Placement A Shares by ASX on the date of this agreement and must use its best endeavours to obtain Official Quotation of the Placement A Shares by no later than 10.00am on the Placement A Settlement Date.

### **3.7 Registration of Subscription Shares**

Immediately following Completion, but by no later than 8.30am on the date of this agreement, the Issuer must register the Subscription Shares in the Issuer's register of members, or ensure the Registry does so, in the name of the Subscriber, free from any Encumbrance.

### **3.8 Constitution**

Upon the issue of the Placement A Shares to the Subscriber, the Subscriber agrees to become a member of the Issuer and to be bound by the Constitution in respect of those Placement A Shares.

### **3.9 Participation in distributions**

The Placement A Shares will only carry the right to participate in a distribution which is declared by the Issuer in respect of the Placement A Shares after the date on which the Placement A Shares are registered in the Issuer's register of members.

### **3.10 Interdependence of Completion obligations**

- (a) The obligations of the Issuer and the Subscriber under clauses 3.1 (**Subscription**), 3.3 (**Subscriber's obligations at Completion**) and 3.4 (**Issuer's obligations at Completion**) are interdependent.
- (b) Unless otherwise stated, all actions required to be performed by a party at Completion are taken to have occurred simultaneously on the Completion Date.

- (c) Completion will not occur unless all of the obligations of the Issuer and the Subscriber under clauses 3.1 (**Subscription**), 3.3 (**Subscriber's obligations at Completion**) and 3.4 (**Issuer's obligations at Completion**) are complied with and fully effective.

## 4 Warranties

### 4.1 Giving of Warranties

- (a) The Issuer represents and warrants to the Subscriber, and the Subscriber represents and warrants to the Issuer, that each of the Issuer Warranties and the Subscriber Warranties (as applicable) are true and accurate in all material respects:
  - (i) as at the date of this agreement; and
  - (ii) as at Completion.
- (b) The Issuer acknowledges that the Subscriber has entered into this agreement in reliance on the Issuer Warranties.
- (c) The Subscriber acknowledges that the Issuer has entered into this agreement in reliance on the Subscriber Warranties.
- (d) Each Warranty must be construed independently and is not limited by reference to another Warranty.
- (e) The Warranties contained in clause 4.2 (**Issuer Warranties**) survive Completion of this agreement.

### 4.2 Issuer Warranties

The Issuer represents and warrants that:

- (a) **corporate existence:** it is a body corporate validly existing under the laws of its place of incorporation;
- (b) **power and capacity:** it has the power and has taken all necessary corporate action to, enter into and perform its obligations under, and carry out the transactions contemplated by, this agreement;
- (c) **authority:** all approvals and Authorisations that are necessary to permit it to enter into and perform its obligations under, and carry out the transactions contemplated by, this agreement have been taken and obtained by it, remain valid and subsisting and have not since been rescinded or varied;
- (d) **validity of obligations:** this agreement constitutes valid and binding obligations upon it enforceable in accordance with its terms;
- (e) **no breach:** the signing and delivery of this agreement and the performance by the Issuer of its obligations under it complies in all material respects with:
  - (i) the Corporations Act;
  - (ii) the ASIC Act;

- (iii) any other applicable laws, or regulations or order of any Government Agency that are binding on it;
  - (iv) the Listing Rules;
  - (v) the Issuer's constitution;
  - (vi) any legally binding requirement of ASIC or ASX (including the ASIC Relief) or
  - (vii) any other undertaking or instrument or Authorisation binding on it;
- (f) **Placement A Shares:** the Placement A Shares will be duly and validly issued and fully paid, free from all Encumbrances (other than those provided in the Constitution) and will rank equally in all respects with the Issuer's existing Shares as at the time of Completion;
- (g) **eligibility for Official Quotation:** the Placement A Shares will be eligible under the Listing Rules and other requirements of the ASX for Official Quotation;
- (h) **listing:** it has not ceased to be admitted to the official list of ASX, nor has removal from the official list of ASX been threatened by ASX, and quotation of its Shares has not been suspended or terminated by the ASX;
- (i) **number of Placement A Shares:** when the Placement A Shares are issued they will constitute not more than 8.15% of the issued ordinary share capital of the Issuer after having regard to the issue of those Placement A Shares;
- (j) **section 708A conditions:**
- (i) the Placement A Shares will be in a class of Shares that are "quoted securities" (as defined in the Corporations Act) at all times in the 3 months before the Placement A Shares are issued;
  - (ii) trading in the Shares on ASX has not been suspended for more than a total of 5 trading days during the 12 month period before the date of issue of the Placement A Shares;
  - (iii) no:
    - (A) exemption under sections 111AS or 111AT or a modification under section 111AV covering the Issuer, or any person as a director or auditor of the Issuer; or
    - (B) order under sections 340 or 341 covering the Issuer, or any person as a director or auditor of the Issuer,

(as modified by ASIC Corporations (Disregarding Technical Relief) Instrument 2016/73) has been made at any time in the 12 month period before date of this agreement;
  - (iv) the Issuer is able to provide, and there is nothing preventing it from providing the Placement A Cleansing Notice in accordance with the Timetable;
- (k) **excluded Information:** the Issuer has no information, other than information included in the ASX Materials, that would be required to be disclosed as "excluded information" under section 708A(7) of the Corporations Act and except as disclosed

in writing to the Subscriber prior to the date of this agreement, the Issuer is not aware of anything that will result in there being any such information prior to Completion;

- (l) **no Shareholder approval:** the Issuer does not require Shareholder approval to agree to issue, or to issue, the Placement Shares;
- (m) **continuous disclosure:** the Issuer is in compliance in all material respects with its continuous disclosure obligations under the Corporations Act and the Listing Rules;
- (n) **Insolvency:** neither the Issuer nor any of its Group Members is Insolvent, and there is no act which has occurred (including entry into or performance of this agreement) nor any omission made which may result in them becoming Insolvent;

#### 4.3 Subscriber Warranties

The Subscriber represents and warrants that:

- (a) **corporate existence:** it is a body corporate validly existing under the laws of its place of incorporation;
- (b) **power and capacity:** it has the power and has taken all necessary corporate action to, enter into and perform its obligations under, and carry out the transactions contemplated by, this agreement;
- (c) **authority:** all approvals and Authorisations that are necessary to permit it to enter into and perform its obligations under, and carry out the transactions contemplated by, this agreement have been taken and obtained by it, remain valid and subsisting and have not since been rescinded or varied;
- (d) **validity of obligations:** this agreement constitutes valid and binding obligations upon it enforceable in accordance with its terms;
- (e) **no breach:** the signing and delivery of this agreement and the performance by the Subscriber of its obligations under it complies with each applicable law and Authorisation binding on it;
- (f) **no Insolvency Event:** no Insolvency Event has occurred in relation to the Subscriber; and
- (g) **professional investor:** it is a "professional investor" as defined in section 708(11) of the Corporations Act and it is a person to whom the Placement A Shares may lawfully be offered and issued in compliance with applicable laws without lodgement, registration or other formality or filing with or by a governmental agency.

## 5 Placement of Placement A Shares

### 5.1 Conduct of Placement

- (a) Subject to satisfaction of clause 3.1, the Subscriber must comply with the terms of the ASIC relief that are applicable to them by immediately offering the Placement A Shares for on-sale and must:
  - (i) use its best endeavours to offer, or procure the offer of, the Placement A Shares for sale at the Subscription Price with investors between 10.00am

and 5.00pm on the Institutional Opening Date (or such earlier time as the Subscriber may determine); and

- (ii) only seek to place the Placement A Shares with investors who it reasonably believes are Institutional Investors.
- (b) The Subscriber may determine allocations of the Placement A Shares by agreement with the Issuer (each acting reasonably), provided that it complies with clause 5.1(a)(ii).
- (c) The Placement A Shares will be entitled to participate in the Entitlement Offer. The Subscriber agrees that it will renounce the entitlements to New Shares attached to the Placement A Shares (**Entitlements**), and authorises those Entitlements to be sold to Institutional Investors under the Institutional Bookbuild in accordance with the terms of the Underwriting Agreement. The Subscriber agrees that no Institutional Cash Return will be payable to it in respect of those Entitlements.

## 5.2 Fees

- (a) The Issuer must pay UBS the following fees on the Placement Settlement Date:
  - (i) an underwriting fee equal to 1.45%; and
  - (ii) a management fee equal to 0.7%,in each case, of the Subscription Amount.
- (b) Provided UBS has complied with its obligations under clause 3.4, the fees payable to UBS under clause 5.2(a) will be payable notwithstanding the Underwriting Agreement being terminated.

---

## 6 Indemnity

Clause 12 of the Underwriting Agreement is incorporated by reference into this agreement, except that:

- (a) references to "Offer Materials" should be read as references to ASX Materials;
- (b) references to the "Offer" should be read as references to the Placement;
- (c) references to "the Joint Lead Managers" should be read as references to UBS;
- (d) references to the "Offer Shares" should be read as references to the Placement Shares and references to the "Placement Shares" should be ignored;
- (e) references to "this Agreement" should be read as references to this subscription agreement;
- (f) references to a Joint Lead Manager of an Indemnified Party should be ignored; and
- (g) other capitalised terms used in clause 12 of the Underwriting Agreement but not otherwise defined in this subscription agreement have the meaning given in the Underwriting Agreement.

---

## 7 Goods and services tax (GST)

- (a) Terms defined in the GST Law have the same meaning when used in this clause or in the definition of "GST Amount" unless expressly stated otherwise.
- (b) Unless expressly stated otherwise, any sum payable or amount used in the calculation of a sum payable under this agreement has been determined without regard to GST and must be increased on account of any GST payable under this clause.
- (c) Subject to clause 7(d), if any GST is payable on any taxable supply made under this agreement to the recipient by the supplier (**Supplier**), the recipient must pay the GST Amount to the Supplier.
- (d) If any GST is payable on any taxable supply made under this agreement to the recipient by the Supplier, the recipient must pay the GST Amount at the same time and in the same manner as making payment of any monetary consideration on which the GST is calculated. The Supplier must provide a tax invoice as a precondition for payment by the recipient of the GST Amount.
- (e) The amount recoverable on account of GST under this clause by the Supplier will include any fines, penalties, interest and other charges incurred as a consequence of late payment or other default by the recipient under this clause.
- (f) If either party is required to pay, reimburse or indemnify the other for the whole or any part of any cost, expense, loss, liability or other amount that the other party has incurred or will incur in connection with this agreement, the amount must be reduced by the amount for which the other party (or its representative member if this is not the other party) can claim an input tax credit, partial input tax credit, or other like offset.

and
  - (iv) is deemed to be received by the addressee in accordance with clause 8.1(b).
- (b) Without limiting any other means by which a party may be able to prove that a Notice has been received by another party, a Notice is deemed to be received:
- (i) if sent by hand, when delivered to the addressee;
  - (ii) if by post, 4 Business Days from and including the date of postage/on delivery to the addressee;
  - (iii) if by facsimile transmission, on receipt by the sender of an acknowledgment or transmission report generated by the machine from which the facsimile was sent, or
  - (iv) if sent by email:
    - (A) when the sender receives an automated message confirming delivery;  
or
    - (B) five hours after the time sent (as recorded on the device from which the sender sent the email) unless the sender receives an automated message that the email has not been delivered,
- whichever happens first,

### **8.4 Costs of performance**

### **8.5 Stamp duty**

### **8.6 Counterparts**

- (b) A single or partial exercise of a right or remedy under this agreement does not prevent a further exercise of that or of any other right or remedy.
- (c) Failure to exercise or delay in exercising a right or remedy under this agreement does not operate as a waiver or prevent further exercise of that or of any other right or remedy.

#### **8.13 Cumulative rights**

Except as expressly provided in this agreement, the rights of a party under this agreement are in addition to and do not exclude or limit any other rights or remedies provided by law.

#### **8.14 Severability**

Any term of this agreement which is wholly or partially void or unenforceable is severed to the extent that it is void or unenforceable. The validity or enforceability of the remainder of this agreement is not affected.

#### **8.15 Further assurances**

Except as expressly provided in this agreement, each party must, at its own expense, do all things reasonably necessary to give full effect to this agreement and the matters contemplated by it.

#### **8.16 Survival and merger**

- (a) No term of this agreement merges on completion of any transaction contemplated by this agreement.
- (b) This clause 11 (**General**) survives termination or expiry of this agreement together with any other term which by its nature is intended to do so.
